Preamble

This Memorandum of Understanding (MOU) confirms the intent of the natural resource management agencies of the states along the Atlantic seaboard of the United States, the Atlantic States Marine Fisheries Commission, relevant federal agencies, tribal governments, and interested non-governmental organizations, to develop and implement an Atlantic Coastal Fish Habitat Partnership (ACFHP). The purpose of the ACFHP is to develop local, regional, state, tribal, federal, and private partnerships that extend beyond the traditional boundaries of resource management agencies and non-governmental organization responsibilities, and establish a commitment to work together for the benefit of aquatic resources. Efforts associated with the ACFHP will focus on supporting the following mission statement:

The mission of the Atlantic Coastal Fish Habitat Partnership is to accelerate the conservation, protection, restoration, and enhancement of habitat for native Atlantic coastal, estuarine-dependent, and diadromous fishes through partnerships between federal, tribal, state, local, and other entities.

Background

A partnership refers to any voluntary collaboration among organizations working toward a common objective. Used to its full potential, a partnership builds synergistically on the time, talent, and support of all partners to mutual benefit and interest. Benefits of partnerships include: 1) enhanced communication, 2) shared purpose, 3) increased resources, 4) shared efficiency, 5) innovative solutions to daunting problems, 6) increased public support, 7) more effective outreach to the public, and 8) increased organizational morale and image for the participants. Based upon the success of the North American Waterfowl Management Plan (NAWMP), the Southeast Aquatic Resources Partnership (SARP) developed an effort based on the concept that private, state, tribal, and federal partnerships must be fostered to accomplish the goals necessary to guide aquatic habitat conservation, protection, and management into the foreseeable future. Implementation of the SARP mission was, and is, dependent on the development of operational plans that are the joint focus of partners targeting high-priority aquatic habitats and ultimately site-specific projects. The success of the NAWMP joint ventures (widely recognized for the increased private and public land set aside for waterfowl and other migratory birds) has been the model for the successes of SARP partnership projects, and will be the guiding force behind those developed for the ACFHP.

A strategic plan for aquatic resource conservation, protection, and management, that articulates how the partnering entities can work together to conserve, protect, and manage coastal, estuarine-dependent, and diadromous fish habitat for the benefit of the American people is needed. The ACFHP will provide the framework for successful implementation of private, state, tribal, and federal partnerships.

The ACFHP was formed following a recommendation from managers at the Atlantic States Marine Fisheries Commission with the realization that many of the habitat issues needing attention fall outside of the jurisdiction of a single agency. Properly addressing these issues

requires collaboration and cooperation with other agencies and organizations to amplify the resources needed to accomplish priority projects.

The attributes under which the ACFHP will operate include the realizations:

- That coastal, estuarine-dependent, and diadromous fish habitats are declining or are in imminent danger of declining, and are rapidly reaching a crisis point, producing a sense of urgency;
- That a consensus-driven process is most efficient;
- That close coordination, trust, and commitment to common goals are mandatory;
- That representation and involvement of informed and supportive public and other stakeholders is both desirable and necessary for support;
- And, that having a positive, measurable impact on aquatic resources will be to the ultimate benefit of the public, states, tribes, and nation as a whole.

Purpose

Having determined that there is a need for developing a joint responsibility to better address the coastal, estuarine-dependent, and diadromous fish habitat resources of the coastal Atlantic states, the partners in this MOU confirm their intent to establish an Atlantic Coastal Fish Habitat Partnership. This partnership will require that all partners move to a higher level of coordination and facilitation of mutually desirable goals, built upon a mutual trust that will focus on successfully completing on-the-ground projects supported by the ACFHP. This will require all partners to rely on closer coordination of those coastal, estuarine-dependent, and diadromous fish habitat conservation, protection, and management activities that are of mutual concern, and work to jointly accomplish those activities through the ACFHP.

The ACFHP is therefore intended to provide overall coordination to conduct and complete work supported by the ACFHP that focuses on coastal, estuarine-dependent, and diadromous fish habitat resource issues and projects throughout the Atlantic States. The need for a unified approach to coastal, estuarine-dependent, and diadromous fish habitat resource management in the Atlantic states is recognized by all of the signatories of this MOU.

Proposed Program

On a watershed, ecosystem, or regional scale, the ACFHP will focus on three primary issue areas that the partners can collaboratively work on to provide the greatest benefit to the coastal, estuarine-dependent, and diadromous fish habitat resources. The primary issue areas are: ecological connectivity, water quality and quantity, and habitat alterations and modifications. Examples of specific concerns that pertain to these issues include, but are not limited to: the effects of land use, improvements to fish passage, advances in sediment management, and aquatic/riparian habitat restoration and protection. These issue areas do not cover everything the partners do, however the ACFHP will focus on those projects that should be joint work efforts.

Authority

Authorization of the parties to this MOU to establish and participate in an ACFHP to jointly address the coastal, estuarine-dependent, and diadromous fish habitat resource issues of the Atlantic states includes the appropriate statutes from each partnership entity (Appendix I).

Commitments of the Parties

The partners to this MOU, to the extent practicable, hereby affirm their mutual understanding and agree to use their best effort to take the following steps:

1. To carry out their mutual intent to design and implement an ACFHP plan that will address on-the-ground coastal, estuarine-dependent, and diadromous fish habitat resource needs throughout the Atlantic states.
2. To work together to facilitate current and future mutually agreed upon joint coastal, estuarine-dependent, and diadromous fish habitat resource activities for the benefit of Atlantic fish habitat resources.
3. To use the resources of their agencies and organizations in a manner consistent with their mission and the mission of ACFHP, that avoids duplication and that mutually supports the efforts of other parties involved.
4. To collectively pursue funding initiatives to support the ACFHP through private, corporate, state, and federal government, and any other means that may be available.
5. To collectively pursue interagency/organization agreements, cooperative agreements, grants, and/or contracts to fund approved projects.
6. To encourage and support the participation of other appropriate agencies and organizations by mutual agreement of the partners.

Resources

Participants in this MOU recognize the critical need for an ACFHP to effectively work for the benefit of coastal, estuarine-dependent, and diadromous fish habitat resources. Participants acknowledge that existing personnel and funding resources are inadequate to fully address fish habitat issues in Atlantic states. Participants also agree that cooperative agreements, grants, and/or contracts are appropriate to fund approved projects, subject to the availability of funds, and in accordance with applicable agency administrative policies and procedures.

Amendments/Termination

Applicable laws and regulations shall govern the liability of the parties to this MOU, to each other, and to third parties, now and hereafter in force. All parties to this MOU must mutually consent to any changes to this agreement. An addendum, signed by all parties will be attached to the original MOU denoting any and all changes.

Period of Performance

This MOU will become effective upon the date subscribed by the last charter signatory and shall continue in force from year to year. Any charter signatory party may revoke their signature with no less than sixty (60) days written notice to the other parties. After such an action, the MOU will no longer be in force for that charter signatory entity. This MOU may be amended by mutual consent of the parties.
